The Imperial County CCP Budget & Fiscal Subcommittee met through the telecommunication service Zoom on Thursday, May 11, 2023 at 1:30 p.m.

Call to Order:

Mr. Marcus Romero welcomed the attending members and guests and called the meeting to order at 1:34 p.m. Roll call was conducted over Zoom.

Approval for continued use of telecommunication services:

Mr. Romero reviewed the recommendation for the extension of online meetings; Ms. Lorraine Martinez moved to approve the extension; Mr. Christian Gonzalez seconded the motion; the motion passed unanimously.

Approval of CCP Meeting Minutes:

After review of the January 12, 2022 minutes, Ms. Eleanor Barraza moved to approve the minutes; Ms. Lorraine Martinez seconded the motion; the motion passed unanimously.

Discussion / Action Item(s):

a. a. Discussion / Approval of funding for staff to attend the APPA 48th Annual Training Institute held in New York City on August 27-30, 2023.

Ms. Sais presented this item on behalf of the Probation Department and stated APPA emphasizes skill building and career development. Ms. Sais noted that the event provides good information for people within the community corrections, civil, judicial educators, probation, and parole fields. Ms. Sais added that the event has great workshops, such as a judge Q &A and attending staff are able to bring back different policies, procedures, or matrix models that could work for Imperial County.

Ms. Lorraine Martinez asked how much is currently available in the CCP Training budget. Mr. Romero responded, stated they generally budget for about \$100k for training and planning events, and stated that since this event would take place next fiscal year there would be enough to cover the costs.

Ms. Eleanor Barraza motioned to approve this item; Ms. Ivonne Peraza seconded the motion; the motion passed unanimously.

b. Discussion / Approval of CCP Budget Fiscal Year 2023-2024

Mr. Romero presented the CCP Budget and stated that it was a standard budget with no major increases aside from the Probation Department due to salary increases. Ms. Widmann asked why this would be presented as an immediate amendment, and Mr. Romero responded and stated that they needed an immediate amendment for additional increases aside from salary and benefits since the Probation Department was looking to provide AB109 staff with cellphones and cover mileage. Mr. Widman noted that due to the timing, it might be possible to include the increase in the budget instead of as an immediate amendment.

Ms. Martinez motioned to approve this item, Mr. Manriquez seconded the motion; the motion passed unanimously.

Agency Updates:

Mr. Victor Manriquez stated that ICBHS was going through a big California payment reform and he was unsure if it would affect the AB109 population. Mr. Manriquez noted that this change will affect billing and how the agency is paid.

No additional informational items or announcements were made.

Dear Board Members,

Requested Action:

The Probation Department respectfully appeals the County Executive Office's recommendation of the following Change Requests – Budget Augmentations with an updated funding source:

- Augmentation Request 897: Request approval to convert an Administrative Analyst I to Administrative Analyst II under Org Key 1028001-Probation to be funded through Community Corrections (AB109).
- Augmentation Request 949: Request approval fund one (1) vacant/unfunded Account Clerk III allocation in Org Key 1028001-Probation to be funded through Community Corrections (AB109).

Background:

With regard to the denial of augmentation request 897 to convert an Administrative Analyst I to Administrative Analyst II this position will continue to be funded through the Community Corrections Partnership Grant funding at a cost of \$4,070 during the fiscal year 2023/2024 with no impact to the General Fund. The Partnership (AB109) account is carrying significant reserves that will ensure this remains a state-funded position for decades to come. The Admin Analyst II has over the past several years absorbed increasing high-level responsibilities related to new state initiatives, grants, and programs. These include Pre-trial Services, Cal-Aim Care Court, and Mobile Probation Services. All requiring detailed responsibilities grant applications, compiling, analyzing, interpreting and reporting data, and identifying outcome measurements and reporting progress achieved.

In regards to the denial of augmentation request 949 to fill an unfunded, vacant Account Clerk III that was vacated as part of the County Retirement Incentive Program, the Probation Department currently has twenty active org keys in which the responsibility of the clerk is to process accounts payables, payroll and utilities. The position will coordinate related accounting activities with other functions. In addition, this position will sort and distribute checks and invoices, and reconcile the department revolving cash funds. The position will be funded

through the Community Corrections Partnership (AB 109) at a cost of \$32,365 for fiscal year 2023/2024 with no impact to the General Fund. . In the out years, funding will remain under the Community Corrections Partnership Grant (AB 109). Which is carrying significant reserves that will ensure there is no impact to the General Fund for decades to come.

Fiscal Impact:

There will be no additional impact to the General Fund for both requested action items, as Community Corrections (AB 109) funds will be used to offset the cost of \$36,435 to fund both allocations in FY2023-2024 and in subsequent years under Org Key 1028001-Probation (General Fund).

Funds will be transferred from Org Key 1847- Community Corrections (Special Revenue) to Org Key 1028-Probation (General Fund) as follows:
