Call to Order:

Mr. Everardo Rodriguez welcomed attending members and guests, and called the meeting to order at 2:00 p.m.

a. Roll Call

Mr. Jose Ramirez conducted roll call.

b. Approval of CCP Meeting Minutes from May 7, 2025

After review of the May 7, 2025, minutes, Mr. Carlos Contreras motioned to approve the minutes; Mr. Don Gorham seconded the motion; the motion passed unanimously.

Agency Updates:

a. Probation Department

Mr. Rodriguez stated that the Department is currently preparing to submit a request to the CCP regarding this year's Adult Re-entry Summit in November and will begin to coordinate with local agencies for the event.

b. Imperial County Sheriff's Office

Lt. Vooris stated that the Inside/Out program will be hosting its graduation ceremony at Imperial Valley College, and this graduated class will have 3 inside students and 10 outside students.

c. GEO Group

Mr. Contreras stated that GEO is scheduling its graduation ceremony on July 10th at the Day Reporting Center and should consist of 18 to 23 participants. Mr. Contreras added that there will be food and drinks provided for the event.

d. ICOE Charter School

Mr. Garcia stated that they had 15 students graduate this semester and summer school will be starting in June. Mr. Garcia noted that they currently have 23 students enrolled currently.

e. SMART Recovery

Mr. Gorham stated that SMART is continuing with its four face-to-face groups in El Centro, Brawley, Niland, and Calexico and its two zoom groups.

f. New Creations

Mr. Ramon Lopez stated that both New Creation classes at the DRC are going well with 6 attending the Spanish speaking class and 15 attending the English-speaking class. Mr. Lopez added that they currently have 15 participants in the men's residential program.
