The APPA Training Institute provides attendees with learning opportunities, which emphasize skill building and enhance career development. Workshops will include activities, audience participation, teaching of new skills, and new research for the field of community corrections. Participants of this training include community corrections professionals in the fields of pretrial, probation, parole, reentry, program and treatment providers, judiciary, criminal justice research, educators, and more.

This conference provides attendees who are focused on improving their core competencies, understanding what works in the field, embracing education and training, and continually updating their skills. All are essential to the success of this crucial work within the criminal justice field, and it all rests firmly on the foundation of belief that this industry has significant impact on public safety.

The Probation Department respectfully requests that the Community Corrections Partnership (CCP) approve and fund the purchase of two (2) vehicles to support field operations, one designated for the AB 109 Unit and one for Pretrial Services Unit.

Since the enactment of California Assembly Bill 109, the department has not submitted a request for additional vehicles assigned to the AB 109 unit, with the last fleet acquisition occurring in 2014. Over time, the existing vehicles have experienced significant wear and tear due to continuous field use, and several units are now reaching or have exceeded their expected service life. This has resulted in increased maintenance costs, reduced reliability, and potential safety concerns for staff conducting field-based supervision and compliance activities.

The AB 109 Unit relies heavily on dependable transportation to perform essential duties, including home visits, compliance checks, and coordination with partner agencies. Similarly, Pretrial Services staff require reliable vehicles to conduct pretrial investigations, court-related functions, and client supervision activities in the community. Ensuring access to safe and operational vehicles is critical to maintaining effective supervision, supporting public safety, and meeting program mandates.

Funding to purchase the two (2) vehicles and ongoing maintenance/operational costs for both vehicles will be supported through CCP funding. However, one (1) Pretrial Services vehicle purchase (one-time monies of \$42,230.22) will be reimbursed by the Pretrial Services allocation funded by Imperial County Superior Court. Investing in replacement vehicles at this time will reduce long-term repair expenses, improve operational efficiency, and ensure staff can safely and effectively carry out their responsibilities.
